Subject: Suggestions about NGOs to contribute their efforts in implementation of Govt. Policies, Schemes and Govt. may apply this to NGOs as mandatory.

Sir, Govt. has studied the functioning of NGOs and recently cancelled many NGO's licences who were involved in susceptive activities / mis use of funds. FCRA is granted to those NGOs who involved in activities like conversion of Hindu's in other religions and mis using the funds. Govt. must check these type of NGOs and their FCRA as well as other donation facilities should be withdrawn as these NGOs.

New Modi Govt. has very good foreseen and New Govt. has invented new schemes for welfare of common people and lower middle class. But Govt. do not have sufficient net work and adequate Govt. machinery through which Govt. could reach the doctrines of newly invented social welfare scheme to the bottom sector of people. Therefore, it is our humble suggestion that NGOs may be made media and NGOs may be entrusted with work of siphoning the doctrines of social schemes up to bottom level sector of Society.

Govt. still not concentrated upon the powerful channel like NGOs. Now the time come that Govt. should use this powerful mass base channel to implement its public welfare schemes through NGOs. We propose that Govt. should make it mandatory upon the NGOs .

Govt. can also utilize NGOs to do monitoring upon the implementation of various Govt. schemes like Pradhan Mantri Gram Sadak Yojana, Pradhan Mantri Awaas Yojana and other irrigation schemes,

educational schemes for down trodden poor section of Society, whether the concerned Govt. Agency is properly running Anganwadi Yojana for students. So also public toilets, erection of electric poles for LED lights, Rural Health schemes to keep watch over basic rights to common people when they appear in Police Station, implementation of special provisions of rules envisaged by New Govt. exclusively for women when the women appear in Police station, a new concept like Kanoon Mitra (friend of Law) may be deputed through NGOs which will help poor sector of people and Govt. shall create a special provision in law for NGO's social workers. Counseling to farmers who try to resort to suicide due to financial crises, loans and natural calamities like famine etc. Govt. NGOs may encourage NGOs and may be provided some facilities to NGOs for this farmer oriented work as now-a-days farmer suicide is the major issue in Loksabha as well as Vidhan Sabha.

Govt. shall give encouragement to pro-Govt. NGOs who are doing study of social problems and giving suggestions to Govt. machinery on sensitive social issued like child labour, mis use of stolen children, beggary act etc. Govt. may provide some facility to the NGOs which are working at grass route level with sincere motive to uplift the down trodden section of Society. Govt. should give little power to NGO workers to enter into Police Station to save the poor victim and to help him to get justice. Many times In charge of Police Station ask question to NGOs social worker who allow you to interfere in the matter who empower you to take side of victim person. So Govt. should do thorough study on this important aspect and arrange to provide at least meager power to NGO social workers on this count.

Govt. should keep watch over such NGOs who mis use NGO's Platform for doing anti-Govt./ anti-national activities like Green Peace NGO, Tista Setalwad's NGOs, Arvind Kejriwal's NGOs, Zakir Naik's NGOs who involved in anti social and anti Government activities. Govt. should also check other religious NGOs who are mis using the FCRA funds/ other donation schemes and facilities provided to NGOs. Govt. should not allow NGOs like aforesaid to take political issue on the platform of NGOs.

Our NGO is willing and ready to accept the responsibility of implementing Govt. schemes amongst the bottom portion of society. Govt. can do this on experimental basis. We feel proud and we feel ourselves as lucky NGO, if Govt. entrust upon us the responsibility of siphoning doctrines of various social welfare schemes amongst the down trodden sector of people.

We appeal before your good self to give necessary directives to concerned Govt. department/ Govt. agencies/ local body to act according to Petition of NGOs. Instructions to that effect may please be given to concerned authority to give priority to the letters of NGOs because common people keep faith still on NGOs rather than the political workers.
