Sub: Compensation/ex-gratia to next of kin of the victims of fire incident in Samjhauta Express.

With reference to your letter dated 6.3.2007 on the above mentioned subject addressed to the Hon'ble Railway Minister, it is stated that Railways grant compensation for deaths/injuries occurring to bona fide passengers who become victims of rail accidents or other untoward incidents. The amount of compensation in case of death is Rs 4 lakhs, which is payable after a decree in this regard is passed by the Railway Claims Tribunal.

Apart from compensation, Railways also disburse ex-gratia at the rate of Rs. 15,000/- in case of death. However, in certain major train accidents/untoward incidents the amount of ex-gratia may be enhanced by the Railway Minister. Thus in case of Mumbai blasts, the amount of ex-gratia was enhanced to Rs 5 lakhs and in the instant case it has been enhanced to Rs 10 lakhs.

We are doing social work in Maharashtra since 12 years and we take great pleasure while writing a letter to a Maharashtrian Minister who is having vast vision over social issues and achieved a crown of most important port folio - Railway Ministry. Hon. Prime Minister of India identified you as a Master of Vision and assigned a responsible Ministry like Railway Ministry.

We being a NGO having deep concern for the victims who caught in the terrorists blast in Mumbai at Western Railway in July 2006. The innocent victims were travelling through First Class compartment. The Railway Department which was headed by the then Railway Minister Mr. Laloo Prasad Yadav had granted Rs.5 lakhs to the family members of Mumbai blast victims. The same Ministry granted Rs.10 lakhs to the victims caught in the parallel incident of terrorists blast took place at Samzouta Express. We being a sensitive social worker noticed the lacuna in process adopted by the Railway authority while granting less compensation to the Mumbaikar victims. In fact the victims caught in Mumbai terrorist blast were travelling in First class Railway compartment who paid 10 times more ticket fare. The Railway department had to consider the insurance aspect proportionate to the first class ticket holders of Mumbai while granting them compensation. The most important thing is the principle of equality as quoted in Constitution of India. The grounds of these two incidents were one and same i.e. terrorists attack. Samzouta express and local train of Western Railway Mumbai both comes under the administrative jurisdiction of one and the same Ministry i.e. Railway Ministry. The density of sorrow is same in the mind of family members of victims caught in terrorists attack took place in Samzauta Express and Western Railway local train. The emotions of family members cannot be

diversified in one and same incidence of terrorists blast took place in Samzouta Express and in local train of Mumbai. There should be no different criteria of sanctioning compensation in one and same incidence of terrorist blast.

We feel that the then Railway Minister respected Shri Laloo Prasad Yadav had given peculiar type of directives to the concerned Railway officers to apply different type of parameter to one and the same incidence of bomb blast. There is a smell of communal attitude adopted by the then Railway Minister because in Mumbai bomb blast case the victims were maximum Hindus and the victims caught in Samzauta Express are belongs to different religion. The citizens Mumbai express their views before us that there is a mathematic of vote bank adopted by the then Railway Minister and therefore maximum compensation (Rs.10/ lakhs) was sanctioned to victims of Samzouta Express with intention to safeguard the vote bank of particular community.

It is the strong protest in the mind of Mumbaites that the life cost of citizens of Mumbai is looked down at low level by the Railway Ministry and they were granted less compensation i.e. Rs.5 lakhs only which is comparatively 50 % lower side than the compensation received to the family of victims caught in Samzauta Express.

We being a social organ isation working in Maharashtra Mumbai appeal before Your Honour to kindly look into the matter personally and give justice to the families of terrorists bomb blast victims of Mumbai.

Sub: - Justice to Mumbai Railway blast victims July 2006.

With reference to your letter dated 20.06.2015 on the above mentioned subject addressed to the Hon'ble Minister for Railways, it is stated that compensation for death/injury of railway passengers in train accidents/untoward incidents as defined in sections 124/124A of the Railway Act, 1989 is decided by Railway Claims Tribunal on the basis of a claim application filed before them. The amount of compensation in case of death is Rs. 4 lakhs, which is payable after a decree in this regard is passed by the Railway Claims Tribunal.

Apart from compensation, Railways also disburse ex-gratia at the rate of Rs. 15,000/- in case of death in an untoward incident as per Railway Board's Circular No. 2011/TC-III/27/29/Ex-gratia dated 07.05.2013 (Annexure –I). However, in certain major train accidents/untoward incidents the amount of ex-gratia is enhanced as per discretion of the Minister for Railways. Thus in case of Mumbai blasts, the amount of ex-gratia was enhanced to Rs. 5 lakhs and in the case of blast in Samzouta Express it was enhanced to Rs. 10 lakhs.
