Sub: Traffic problem arise on road adjacent to petrol pumps which provide CNG & LPG gas.

Need to set right the discrepancy in policy of implementing CNG and LPG policy.

Respected Sir,

At the outset we convey our best wishes and gratitude for adopting nature pro and pollution less petroleum policy by Govt. of India by introducing CNG and LPG kits for vehicles. It is really an appreciable step taken by Govt. of India as a noble duty to protect Ozone cover of this earth. By adopting CNG and LPG policy we could save our foreign exchange currency which earlier consumed on huge level to buy more and more petrol from gulf countries. This is a step to march towards self reliant India which is the main motto of Modi Sarkar.

We would like to humbly suggest Your Honour to please take cognizance of discrepancies arise while implementing CNG and LPG policy which needs to be settled forthwith.

- There are quite meager no. of petrol pumps where facility of refilling CNG and LPG gas is available. No. of vehicles having CNG and LPG kit are very large and refilling centres are quite insufficient. There is need to install CNG and LPG refilling centre in each and every Petrol pump.
- 2 Due to meager no. of refilling centres there is road block in the vicinity of every petrol pump which caused to hamper traffic system of city.
- 3 Vehicle owners are compel to devote valuable time i.e. hours together every day unnecessarily for refilling the CNG and LPG gas in the Queue of petrol pump.

- Auto rickshaw walas are the poor section of Society. They compel to waste huge time before petrol pump which they could utilize to earn their bread and butter. It affect adversely on their daily income and it affect on standard of living too.
- 5 Due to road block Ambulance and emergency service vehicles have to detain in traffic jam and their fuel is consumed unnecessarily as well as the patients in ambulance are suffering from danger to life.

Till the time CNG and LPG are not provided in adequate quantity, there should be restriction on production of such vehicles and directives be given to automobile industries that they should do only 3 % production of vehicles which are having CNG and LPG.

There should be proper liason in between Ministry of Petroleum and controlling authority of manufacturers of vehicle. Govt. should check whether proper refilling system is made available by Ministry of Petroleum prior to giving permission for production of such vehicles which are having LPG/ CNG Kits. The main factor is to be given priority that member of public/vehicle owners should not be suffered in this Nation.

RTOs to be given instructions to stop giving permission to convert petrol engine into CNG and LPG engine in the vehicles till the time sufficient quantity of CNG and LPG refilling centres are not made available by Govt.

We would like to humbly suggest Your Honour to kindly search some strategy to allot CNG and LPG refilling equipment to unemployed youths who are having their own land adjacent to main road in city/ village whereby the no. of CNG and LPG refilling centres shall be enhanced and proportionate ratio in between CNG and LPG refilling centres and no. of vehicles shall be maintained properly. The road traffic jam problem shall be eradicated. Monopoly of petrol pumps shall be finished and unemployment problem of India shall be settled to considerable extent. Parents of unemployed youth shall give blessings to Modi Sarkar if their son / daughter get easy employment in their own land.

This is a representative feeling of huge population of India who are having CNG and LPG kit in their vehicle. Kindly take cognizance of this sensitive issue and start studying on above proposal with positive sense.


