With all respect to constitutional Head of India His excellency President of India, we would like to submit following few lines for your kind perusal.



Subject : Remedial steps to curb unfair election practice, humble suggestion for reform put forth by Conscious Citizen Forum for good governance.

Respected Sir,

Purifying election process is quite necessary for establishing an ideal democracy in the country. We would like to throw light on this issue. We therefore request Your good self to kindly go through following few lines.

No educational criteria is there in election process. There is no yard stick of educational eligibility while contesting the election.

When an illiterate and uncultured political leader is elected and sent to the House, there is possibility that he/ she may break the procedure of good governance. Proper training cannot be imparted to these illiterate member of house. So such type of illiterate and uncultured members do not understand the holiness of House. It becomes very difficult for House to maintain its standard.

In our country rate of literacy is quite low. The tribal part of country must get representation in house. So applying the educational eligibility cannot be made mandatory for contesting the election.

But when ruling political party give portfolio of Minister, the criteria of certain educational eligibility must be observed. Portfolio of Ministers must be entrusted upon to the member of House who is at least Graduate because Minister has to monitor the administration comprising IAS and IPS officers. If uneducated person becomes Minister, bureaucrat can dominate the administration and they will effect each and every decision of Minister. So the governance of public representative becomes weak.

After nominating the member as Minister, by organizing special evening classes where training of Parliamentary procedure shall be imparted to the upcoming Minister.

We submit our suggestions for good governance as follows :-

Election Commission may form **moral policy / parameter** for political parties / independents.

Election Commission may adopt the policy of CRISIL rating to the political parties / independents.

Minus ranking may be given to such :-

- A. If any political party give maximum numbers of candidates having criminal back ground.
- B. If any political party give maximum numbers of illiterate candidates.
- C. If any political party give maximum numbers of candidates who are over age like 60 +
- D. If any political party do not keep proportionate parameter for women candidates/ minorities/ backward SC/ ST/ Economical Back ward classes etc.
- E. If the members of House of any political party are habitual in remaining absent in the House and / or percentage of attendance in House is very low.
- F. If the members of House of any political party are not raising question in the House and keep mum. If the members of House of certain political party are raising very meager figure of question throughout their tenure.
- G. If number of miscreant members are in large number in certain political party who disturb the smooth functioning of House due to which House is adjourned and day to day work is held up for a day.
- H. If candidate of political party or itself a political party do exorbitant expenditure in election campaign.
- I. If candidate/ political party violate maximum code of conduct.

The criteria to be fixed for ruling party.

- A. If name of the MLA or MP belongs to ruling party is facing allegation of involving in any scam, political party must have to disqualify that member of House, that political party should take moral responsibility and must take appropriate action against that member of House immediately without waiting for public agitation and / or verdict of Court.

B If the ticket is being given to the candidate who faced allegation in scam in his past tenure in house, by certain political party.

Plus ranking may be given to such :-

A. The political party/ Independents who avoid above all negative things be given plus ranking.


Political Party / Independents may made it mandatory to write their rating below the title of the name of their political party they published in public.

For healthy democracy, process of purifying election process is quite essential.

If Election Commission study the above contents, we hope our suggestions shall be proved salutary for purifying the election process in this country. We shall be happy if Election Commission and / or Govt. appeal to the think tanks in political field to hold open debate on this most sensitive issue.
